Rules and Regulations for Pageant Contestants

1. Contestants must be a resident of Lincoln County.
2. Contestants must be single and never been married, or had a marriage annulled.
3. Contestants must be a rising high school senior as of the Fall School Year and no older than 23 years of age as of September 30th.
4. Contestant must be of good moral character, shall not have been convicted of any crime; and shall possess poise, intelligence, charm and beauty of face and figure.
5. Contestant will be judged in three categories: Interview, Swimsuit, Evening Gown and on stage question. (Guidelines will be provided for acceptable apparel and must be approved).
6. Contestant selected as the Apple Queen should make a maximum effort to be at all requested activities for the next twelve months.
7. If the Apple Queen becomes ineligible, the first runner-up will be required to assume the title and related responsibilities.
8. Each contestant is required to provide photographs (instructions regarding photographs are listed on the last page of this application - follow precisely), copy of birth certificate and one other form of identification.
9. Completed entry application should be dropped off at the Chamber of Commerce, 101 E. Main Street, Lincolnton. Please use white paper only, do not staple and do not fold. These will be used to make multiple copies for the judge's books. Drop off **NO LATER THAN** June 10th.
10. Contestant must be present for all rehearsals and planned functions pertaining to this pageant. Any contestant missing more than two rehearsals may be disqualified.

INSTRUCTIONS FOR PHOTOGRAPHS APPLE QUEEN PAGEANT

1. Schedule appointment with photographer JJ Tindall at Tindall's Professional Photography 704-748-1998. Located at 5215 E. Hwy 27, Iron Station, NC 28080. Check out their website at www.tindallsphotography.com to see samples of photos in the "Galleries" section for the last Apple Queen Pageant.
2. The photographer suggests that you need to have your photos taken prior to June 10th to allow time to process and get them to the pageant chairman.
3. Be certain to tell whoever schedules you that you are an Apple Queen Contestant and need the BPW rate which will be \$55.00. You will be responsible for the \$55.00 fee; however, the photographs are yours and will be returned to you after the pageant. You will receive (4) 4x6 size photos two black & white and two color.
4. You will need to arrive for photos **READY**. That means hair and makeup done. It is suggested that you wear a strapless bra and a button front blouse as you will be draped for the photos.
5. You will have the opportunity to select your photo which will be used. Photographs are used for publicity purposes and the program booklet.
6. The photographer will provide your photos to BPW and we suggest that you "do not wait" until the last minute. The photographer stays busy with proms, graduations and weddings during May and June. If you are certain about competing in this year's pageant, schedule your appointment right away.
